CYSA Board Meeting March 11, 2021 MINUTES

President's Report: Advertisement in local newspaper went out. Elections for the new Board are scheduled on April 14, 2021 during our Annual Meeting.

Treasury Report: Terry shared the balance of both Travel Account and County Account.

Travel Team Coordinator Report:

- Season started March 6th and ends on May 9th. There are 5 travel teams, one playing NFYSL and 4 FL Club D-League: U12 Cyril & Don; U13 Chris & Mike; U15 Jason, Greg & Jimbo; U17 Girls Raul & Star; and U17 Boys Conrad, Lopez, & Trevor
- League has heavy fines if games are rescheduled (\$1,500 per incident) but we have had several requests for changes already. Not sure if the League really collects these fines.
- We are down to one crew of senior referees. Jay can give more information on that. We should receive referee fees from Clay county (\$160) for a game cancelled on March 7th, U13 team.
- Raul was able to use the yearly rebate from FYSL to purchase ice packs for teams and will give one box to Jay to have available for home games.
- Raul was also able to use rebate from Soccer.com (travel) to purchase two 21X8 nets.
- He also purchased goalie jerseys for travel teams and had them customized with the CYSA logo. Need to get one more for Cyril's team, but waitig on sale event at soccer.com. He will need reimbursement for the customization of the jerseys (Print City \$73.71) and will bring receipts to Terry.
- The U13 and U17 Boys teams are going to be participating on the FL Club Development League Cup Final Four Championships on May1-2 in Melbourne.
- Special Board Review/Determination since last meeting: Request from U15 player to play up and move to U17 team. The Board decided against the player's request based on: 1. CYSA encourages age appropriate participation in travel teams, especially when there is a team of the player's age and the same skill level. 2. Player committed to his current team when he signed up to play during the 2020-2021 season.
- A 2004 player requested to be released from CYSA to go play with another club. He paid the release fee (\$300). Working on release.

Recreational Season Report: Star conveyed that the season went well, it ran smoothly for the most part. Trophies and medals were bought from Epicm and they messed up the order making it necessary to purchase labels. Will use another vendor next time.
